Participation in a CA is conditional upon receipt of the capacity auction deposit by the published date.

⁵ Participants that cannot post or update their capacity prudential support by this date are encouraged to speak to the IESO to ensure their prudential support can be processed prior to the start of the obligation period.

⁶ Participants registering a new demand response resource must complete CMP authorization, including posting capacity prudential support, prior to finalizing resource registration. Refer to New Demand Response (DR) Resources Section in the Forward Period table.
