### Location-Specific Settlement of Global Adjustment

What questions do you have on presenting Global Adjustments charges on a settlement statement by location (delivery point)?	As noted by the IESO in its follow-up correspondence on June 29, 2021, there is significant confusion about the IESO's proposed change. The EDA agrees that worked examples of the proposed change would provide clarity with respect to the proposed change and would enable the EDA and its members to provide more thorough commentary. The EDA anticipates that the IESO will provide an appropriate period of time after the requested materials have been made available for the EDA and other parties to comment.

## General Comments/Feedback

With respect to the IESO's overall process, the EDA questions why the RSS engagement has been merged with the MRP Detailed Design consultation. We observe that the IESO did not include the RSS in the IESO's MRP Detailed Design documents and that the IESO has completed engagement on the MRP Detailed Designs. The EDA suggests that the IESO confirm whether the RSS will inform the preparation of further amendments to the MRP Detailed Design that the IESO will consult on and the EDA looks forward to learning the IESO's thinking on the appropriateness of expanding the Detailed Design to include RSS. The EDA's members will benefit from transparency of the IESO's thinking and approach, it will support them in responding to their customers' inquiries when MRP is implemented as of November 2023.

Further, we note that the IESO is consulting on several changes to the MRP Detailed Design as part of the Implementation phase. The EDA asserts that increased transparency and detail of the overarching Detailed Design documents, including changes thereto, is expected to assist all parties. The EDA sees value in the MRP Detailed Design being prepared so that it can serve as a guide to the "as implemented" MRP when it goes live in November 2023.
