### About the IT Release Plan

Four times a year, the IESO coordinates a release package of changes to IESO systems that will impact users outside the IESO. These changes are categorized as either

- **Category 2** change (users will have to make a functional change, such as an update to a procedure)
- **Category 3** change (users will have to modify a technical interface with an IESO system or solution)

The [IT Release Schedule](#) provides the planned dates for each release. Dates for specific changes may differ from the calendar dates, but will be provided in the Release Plan.

- **Sandbox Implementation** is the date the change is deployed on the IESO Sandbox environment, used for testing and training
- **Production Build** is the date the change goes live. This may happen during **Real-Time Build** (for systems used to interact with the IESO-Administered Market) or **Non-Real Time Build** (for other systems used to interact with the IESO, such as those used for settlements or registration activities)

Efforts are made to minimize the impacts of system outages during planned releases. **Planned outages** are posted in advance on the IESO website's [Planned IT Outages](#) page.

For each planned release, three versions of the Release Plan are published: the **Preliminary Release Plan**, the **Target Release Plan** and the **Final Release Plan**. Any additions from the previous version of the plan are highlighted in yellow. Any items that have been removed are shown with a strike-through.
