	Current Engagement Initiatives - Status Update
Capacity Exports	The IESO is working on the development of internal processes to support capacity exports. This is currently being developed but will be presented to stakeholders as proposals for comment when ready.
Enabling System Flexibility	The IESO has further investigated the nature of Ontario's system flexibility need and met with other US ISOs to discuss their experiences with enabling system flexibility. The IESO held a stakeholder meeting on January 27 to present findings from the meetings and discuss in detail some of the requisite characteristics of flexible resources and proposed activities to address the flexibility need in the near term. Feedback to issues discussed in the meeting is due February 17.
Market Renewal	The IESO has extended the deadline for feedback to January 30 for stakeholders to provide feedback on materials and issues discussed at the December 19 meeting. The next stakeholder meeting will take place on February 24 where IESO will respond to feedback and outline next steps for the project. Additionally, Market Renewal Education Workshops will be hosted in February in order to provide stakeholders with a chance to better understand each market design change element.
Conservation Framework: Mid-Term Review	The IESO has selected the Conservation Framework Mid-Term Review Advisory Group members. The Mid-Term Review Advisory Group will meet in February where members will have an opportunity to provide input to the scope of this initiative. The first meeting of the broader engagement initiative is expected in early Q2, 2017.
Provincial Energy Managers Program  Development	Stakeholders were invited to provide comments on the proposed scope of work for the Sector Based Energy Efficiency Program. The IESO will consider and respond to feedback shortly.
Real-Time Generation Cost Guarantee	The IESO continues to engage with stakeholders on proposed elements for a new cost recovery framework for the RT-GCG program. Stakeholder feedback will be considered in the development of a revised market rule package for consideration by the Technical Panel at its February 14 meeting.
Review of the Interim Market  Document Change Process	A webinar was held on January 19 to provide background and seek input from stakeholders to help shape an internal review of the Interim Market Document Change (IMDC) Process. The IESO will consider and respond to feedback later this month.
