The table below lists the supporting documents that are required for each type of Eligible Participant. These documents must be submitted to establish that the Applicant is an Eligible Participant under the microFIT Program.

In addition to the documents listed in the table below, if you are applying for (i) a wind Renewable Generating Facility that has a Nameplate Capacity of 3 kW or less, or (ii) a Non-Rooftop Solar Facility, you must submit a zoning opinion or zoning certification pursuant to Section 3.2(b)(2) of the microFIT Rules as part of your Application.

The table below is intended as a guide and for ease of reference only. Additional information about each document listed below, as well as a description of each type of Eligible Participant, can be found in the microFIT Eligible Participant Schedule.
