Hydro One Networks Inc. (Hydro One) generally supports the proposed market rule amendments MR-00212-R00, MR-00212-R01, MR00212-R02 and MR00212-R03 resulting from the SE-23 Prudential Review Report. Hydro One appreciates the opportunity to both participate on the SE-23 stakeholder group and the opportunity to comment on the proposed Market Rule amendments. This includes support of the proposed amendment to section 5.8.2 to specify the conditions under which the IESO shall be obligated to automatically reduce a market participant's credit rating by "one-notch" rather than by "one category". Hydro One supports a new subsection 5.1.2 to specify that the IESO shall review the prudential support requirements at least once every three years and that the first review shall be completed no later than September 1, 2010.

There is one section in MR-00212-R02 that Hydro One does not support. In section 5.8.4, Hydro One does not support the amount of increased credit for unrated Direct customers with greater than 6 years of good payment history. Hydro One believes this amount of increase creates a default risk that cannot be mitigated through timely disconnection and is out of step with the year-over-year increase in unsecured credit for such customers with shorter periods of good payment history.
