- The Service Provider is maintaining, and shall present upon request, documentation necessary to support this Consent to Verify, and shall inform, in writing, the Independent Electricity System Operator ("IESO") and all persons to whom this Consent to Verify was provided by the Service Provider of any changes that would affect the accuracy or validity of this Consent to Verify.
- The Service Provider hereby authorizes IESO, the IESO's authorized representatives, and any independent auditor identified by the IESO, to verify that the Service Provider performed or contributed towards the above-noted Designated Activity materially in the form as set out in Exhibit C or D, as applicable. Such verification shall include the rights to reasonable access to the relevant and appropriate individuals, financial and operating records and data kept by the Service Provider relating to the Designated Activity set out above ("Required Information") sufficient for the IESO to determine compliance by the Supplier with the FIT Contract and in particular Exhibit C or D, as applicable, thereto. The Service Provider further agrees that it shall, and it shall ensure that its contractors shall, keep and maintain all books and records, including such agreements with consultants and other service providers, necessary to support the Required Information for a period of not less than seven (7) years from the date of this Consent to Verify. The Service Provider agrees that the IESO shall be entitled to request copies of, and access to, such books and records from time to time during such period.
