CMSC Recovery from Electricity Storage facilities IMDC-74 1.0	All	On June 22, 2021, clarifications to market rules (Omnibus 2021), which included market rule amendment (MR-00449-R01), was communicated to the Technical Panel. The market rule amendment was posted for stakeholder review and comment at the June 29, 2021, Technical Panel engagement. IMDC-74 is effective December 1, 2021. MM 5.5 will be updated March 2, 2022 as part of BL 47.0.	2	<p>Reason For Change</p> <p>On March 10, 2021 the IESO Board approved new market rules that enabled the recovery of congestion management settlement credits (CMSC) from dispatchable loads when those payments were a result of actions taken to prevent endangering the safety of any person, equipment damage, or the violation of any applicable law (SEAL). The new section 3.5.6G of Chapter 9 closely follows a similar provision for dispatchable generation in section 3.5.6C of Chapter 9. This section was edited in MR-00446 to integrate electricity storage resources, specifically by including electricity storage facilities that can inject. To retain consistency with 3.5.6C, the amendments that enable recovery of CMSC from dispatchable loads should also include electricity storage that can withdraw.</p> <p>Description of Change</p> <p>Section 1.6.9.4 of M.M 5.5 will be updated as a result of the MR-00449-R01, Ch.9 section 3.5.6G.</p> <p>Description of Impact</p> <p>Dispatchable Electricity Storage Facility that Can Withdraw need to be aware that, as per this update, they are eligible to CMSC adjustments similar to dispatchable loads as detailed in Section 1.6.9.4 of M.M 5.5.</p>
