

NOTICE OF A HEARING

The Independent Electricity System Operator has applied to amend its licence El-2013-0066

The Independent Electricity System Operator (IESO) is asking the OEB for approval of the following changes to its licence:

- To include in section 1 Definitions a new definition called "Market Rule Amendment Proposal" that describes a set of Market Rule amendments that were the subject of a formal stakeholder engagement, reviewed by the Licensee's Technical Panel and approved by a vote of the Licensee's Board of Directors
- To streamline the filing requirements in section 6 Provision of Information to the Board by amending sub-sections 6.3 i, ii, iii and v to remove the need to file preliminary or outdated designs and related documents
- To update the name "Stakeholder Advisory Committee" to "Strategic Advisory Committee" in sub-section 6.3 iii
- To delete sub-section 6.3 iv, which will be subsumed by sub-section 6.3 iii

The IESO indicates that the proposed changes to certain sub-sections of 6.3 of its licence would substantially reduce the volume of documents filed at the outset of the application related to preliminary designs that the OEB does not need as part of its review of the final Market Rule Amendment. The IESO believes that reducing the amount of material will create a more efficient and timely process.
