Dear Ms. Flude,

Thank you for inviting the City of Mississauga to participate in the webinar discussion on the Regional Electricity Planning Peel/Halton (GTA West) 2021 Integrated Regional Resource Plan (IRRP). The webinar presentation has been viewed by staff in the Transportation and Works Department and other City Departments with the following comments outlining issues that may be associated with the development of the IRRP and impacts to lands located in northwest Mississauga.

Further to our previous comments (June 5/20) the City's Planning Strategies Division provide the following general comments.

- Mississauga staff see that one of the options to address the Halton Pocket need would be a transmission line between Meadowvale and Hurontario stations (along the northwest border of the City). Staff have flagged this for now and will be monitoring if it becomes a feasible option once IESO does their detailed analysis.
- Mississauga staff want to better understand how the IESO is accounting for the growth forecasts issued by the Ministry of Municipal Affairs and Housing, as within the last two months updated growth forecasts were released and the planning horizon was extended to 2051. Our Official Plan will also not have updated and Council approved growth forecasts until after 2022 when the Region of Peel completes their Municipal Comprehensive Review and assigns local growth forecasts.
- This is tangentially related to the IRRP but the City's comments from the Northwest GTA Transmission Corridor Identification Study could still be applied here – the City previously provided comments for the Study through the Region on July 9, 2020 Council Report, Item 7.1 and 15.1. Our comments focused on the impact of the proposed transmission corridor to developable lands in Ninth Line Lands, Meadowvale Business Center Corporate Park, and nearby Lisgar GO MTSA. The IRRP should be considering the impact of the options on the City of Mississauga's developable lands. This is especially as we work with the Region of Peel to allocate the Growth Plan (2019)'s growth forecasts and plan our land budget.
