Large-Scale Team Member Experience / Section 3.2 (a)

Bedrock Energy Corp. ("Bedrock") believes that requiring an applicant that is submitting to the RFQ via the Team Member Mandatory Requirements avenue to demonstrate that they have achieved a Commercial Operating Date ("COD") for a past project in any jurisdiction in Canada or the United States of America no more than 15 years prior to the date of the RFQ submission, in accordance with the definition of a Qualifying Large-Scale Project, as prescribed in section 3.3(a)(i) of the most recent Draft RFQ (dated April 22, 2022), is unnecessarily restrictive. For example, taking into account the recent historic development context in Ontario, there have not been many dispatchable, non-renewable generation and no grid-scale energy storage developments constructed in this timeframe. This 15-year is respectfully too short; that timeframe essentially only reflects the procurements conducted by the predecessor to the IESO, the Ontario Power Authority, in the early-to-mid-2000s, and nothing of significance beforehand. Alternatively, Bedrock suggests that there is benefit of available experience if the IESO were to extend this requirement to 30 years, which is a timeframe more reflective of previous large project builds in Ontario.
