### **IT Solutions Progress**

The slide showing the IESO's progress in developing software solutions is attached. As noted in the last memo, the IESO completed User Acceptance Testing on portions of Online IESO related to Registration activities. User Acceptance Testing is in progress for Demand Forecasting System, and Factory Acceptance Testing has commenced for the Market Information Management System.

The Market Information Management (MIM) system and the Dispatch Services API technical specifications are currently available on the <u>Market Participant Readiness webpage</u>. Schemas and sample files for reports, as well as technical specifications for settlement statements will be provided over the coming months and into 2024.
