- f. Apart from the completion of any blanks, drop down lists, check boxes or similar uncompleted information in a Prescribed Form, no amendments may be made to the wording of a Prescribed Form.
- g. Each Prescribed Form must be completed in its entirety, except for fields or sections that are specified as not applicable to the Qualification Submission. Fields marked <if applicable> must be completed if applicable to the Qualification Submission.
