# Quarterly Report on the Market Renewal Program Status

<sup>&</sup>lt;sup>i</sup>The Schedule Performance Index (SPI) is a measure of the conformance of actual (earned) progress to the planned progress and is calculated as: SPI = earned value / planned value.

ii The Cost Performance Index (CPI) calculates the cost efficiency of the project through the following formula: CPI = earned value / actual cost.

Frevious baseline (BL4) is the MRP project schedule which estimated a go-live date of November 2023. As 2023 was the last year of the program the BL4 annual budget column is no longer being reported.

iv The in-effect baseline schedule, also referred to as current baseline 5 (BL5), estimates a May 2025 go-live date.

#### **#6: Quarterly MRP Milestones Progress**

In December 2023, the IESO performed a comprehensive review of the key project milestones for 2024 and 2025 informed by experiences and lessons learned over the previous 15 months of implementation since the Board approved the revised schedule and budget in August 2022. As a result, the remaining project milestones have been revised to emphasize key market participant facing activities while maintaining critical path milestones and incorporating learnings for schedule optimization to neutralize risks to the MRP schedule and budget. The updated list of key milestones includes 20 milestones planned for 2024 and seven milestones planned for 2025.
