Objective

Review, inform, and discuss with Metered Market Participants (MMP) and Metering Service Providers (MSP) changes and updates with regards to revenue metering in the IESO-administered markets.

 - 3.1 IESO presented performance metrics for MSPs and also raised improvement opportunities regarding Measure 11 "Timely Submission of Commissioning Reports".
 - 3.2 IESO updated committee on new TIM and conforming meter list updates. MSP raised question on whether Schneider has submitted the ION 9000 for addition to the CML. IESO has indicated no submission has been made and MSP can contact Schneider in order to get the application process started to submit to the IESO.



- 4. Meter Registration Hotline Activities and Enchaments
 - 4.1 IESO presented an update of the hotline registration activities and also the potential changes EUR requirements. MSP raised a question on the difference between True Load vs Injected Load injected current requirements (currently 0.1A and 2.5A respectively). IESO has indicated that it is to mainly differentiate between what is true load vs injected load by having a higher current requirement for the injected load.
 - 4.2 IESO presented a summary of the 2020 Audit program and enhancements to the meter registration process. A question was raised if the IESO plans to audit sites further than a 1 day drive in 2021. The IESO is optimistic that these installations can be audited in the future and will plan for it (but will also be prepared to scale down the audit plan based on the pandemic situation in 2021).

5. <u>Resettlements Process (Morela Rodriguez)</u>

5.1 IESO presented an overview of the proposed changes to the settlements process. A question was raised on any assessments or quantitative analysis that supports moving to a two year period for IT spot checks (likelyhood and materiality). The IESO indicated that there will be future opportunities to raise further questions and concerns as part of the formal stakeholdering process for this initiative (the presentation provided at the RMSC was intended to introduce high level concepts, where the IESO was heading, and bring the MSP community into the fold early on).

6. <u>Rountable</u>

6.1 MSP raised a question on whether IESO can aid in providing any training materials to the MSPs in order to make an easier transition for new staff on the MSPs side. (Action Item)
