<MARKET_TYPE>	"10-char " will be "OPER_RESV".
<PARTICIPANT_ID>	12-char" will be the name of participant.
<USER_ID>	Currently not used – field will be null.
<DELIVERY_DATE>	"8-char" will be the dispatch date in the format of "YYYYMMDD".
<BID_TYPE>	"10-char". Valid values are "GENERATOR", "LOAD", "OFFTAKE" "INJECTION".
<RESOURCE_ID>	"32-char" will be name of the Resource.
<TIEPOINT_ID>	"32-char" If <BID_TYPE> is "INJECTION" then <TIEPOINT_ID> will be present.
<HOUR>	"2-char" will be in range of 1-24, e.g. HOUR 2, means hour ending 2.
<INTERVAL>	"2-char". 1 indicates first interval in the hour,..., 12 indicates the last interval in the hour.
