It is understandable that the 10 Year outlook references be removed from the Market Rules with the change in IESO responsibilities. However, in the removed Chapter 5 Section 7.3.1.1 and Chapter 10 Section 7, the annual report was required on or before April of each year. Under the proposed amendment, there is no target publishing date for 10 year assessment.

However, it is suggested that a statement be included in the rule change on when the IESO/OPA assessment either is to be or could be published by either the IESO or OPA, which ever is applicable. This is needed to allow Market Participants to know when an assessment should or could be expected each year to allow Market Participants to use these assessments in their planning.

Market Participants are obligated to submit data under proposed changes to Market Manual 2.8 around 01 December each year. As this indicates that the IESO is collecting data on a set time, there must be an expected publishing date. The date is not obligated and can be noted as such in the rules but there should be a guideline date or indication to the Market as to when this report will likely be available.
