Hydro One Networks Inc. fully supports this Rule Amendment needed to correct the existing inconsistency on the applicability of the NERC and NPCC Reliability Standards in Ontario and we appreciate the opportunity to provide the following comments:

Section 1.2.6:

Subsections 1.2.6.1 and 1.2.6.2 refer to timing that standards shall be declared in force while subsection 1.2.6.3 does not. Subsection 1.2.6.3 is a condition to use the timing subsections. For clarity, Section 1.2.6 should be as follows:

- 1.2.6 Subject to section 1.2.7, reliability standards established by a standards authority that have not otherwise been stayed or revoked and referred back to the standards authority for further consideration by the *Ontario Energy Board* shall be declared in force in Ontario:
 - 1.2.6.1 whenre the reliability standards are declared in force in the United States or, for NPCC reliability criteria, when declared in force by NPCC; and
 - 1.2.6.2 after the expiry of the period for initiating a review before the Ontario Energy Board and the conclusion of any such review.; and
 - 1.2.6.3 where the reliability standards have not otherwise been stayed or revoked and referred back to the standards authority for further consideration by the Ontario Energy Board;

and shall cease to be in force in Ontario when they cease to be in force in the United States.

Definition of *standards authority*:

As written, the definition means that a *standards authority* is only one of the cited bodies at any given time as it would allow for no more than one of them being a standards authority. To reflect the intended meaning, the proposed definition should be changed as follows:

standards authority means NERC, NPCC, any successors thereof, or and any other agency or body that approves standards or criteria applicable both in and outside Ontario relating to the *reliability* of transmission systems;
